FT.\$975,000Pedigree: Fast-rising Los Angeles architecture studio Oller & Pejic collaborated with Marc Atlan, a creative director, to devise this enigmatic 2012 house, wrapped around a central courtyard and set in a remote stretch of the Mojave Desert overlooking Joshua Tree National Park. The home's black-stucco façades are meant to evoke shadows on the landscape, while its form takes inspiration from the work of Frank Lloyd Wright and Rudolph Schindler. Property Values: The two-and-a-half-acre grounds include a pool and carport. Talking Point: Urbanites needn't fear the seclusion; Palm Springs is just a 30-minute drive away. FT. \$1.8 MILLION Pedigree: Designed by AD100 architect Hugh Newell Jacobsen in 1988, this white painted-brick residence (dubbed A Village of One's Own) just outside Philadelphia is distinguished by a gabled roofline inspired by New England vernacular building styles. Dormers and floor-to-ceiling windows drench the crisp interiors in sunlight. A dramatic spiral staircase leads to the master suite and library on the house's lower level, which, by virtue of being built into the sloped site, opens onto the surrounding lawns. STATS4 BEDROOMS4 BATHROOMS2 HALF BATHS5,600 SQ. FT.\$4 MILLIONPedigree: Stormfield, a bucolic 30-acre estate, is famous for being the onetime home of author Mark Twain. Today the handsome Mediterranean Revival manse, a 90-minute drive from Manhattan, brims with period charm, thanks to coffered ceilings, turned-wood balustrades, and wide-plank floors. Talking Point: Twain named the grounds after "Captain Stormfield's Visit to Heaven," the last story he ever published.Property Values: The four verdant acres also contain a barn-style garage (with lofted living space) and a bluestone-paved terrace.
